



## 2016 Vendor Contract: Lewiston Hot August Nights Main Streets Auto & Cycle Swap Meet

Welcome to Lewiston's Hot August Nights annual swap meet! You are invited to apply for a vendor space at the 2016 Lewiston's Hot August Nights Swap Meet, coordinated by Beautiful Downtown Lewiston. **Swap Meet dates and hours are Friday, August 26<sup>th</sup> & Saturday, August 27<sup>th</sup> from 10am-6pm.** We want to see this event grow and hold our goal in making this a fun and enjoyable event for everyone. We ask for your cooperation and compliance with our following rules and regulations.

**Note: This show is strictly for automobile related items. Automobiles, cycles, or related parts are welcome. The LHAN committee has the right prohibit any item we believe it is not automobile related.**

The requirements for participation and agreed to by both parties involved are as follows:

1. **Right of Refusal:** The LHAN reserves the right to refuse rental of vendor space to anyone and to exclude or reject without recourse any person who has violated these rules, or is otherwise objectionable.
2. **Alcohol:** Consumption of alcoholic beverages on the grounds of the swap meet is illegal and prohibited.
3. **Cars for Sale:** If you are selling a car it must be present in your booth space.
4. **Animals:** No Dogs or other animals are allowed on the Swap Meet Lot.
5. **Electricity:** We do not supply extension cords or guarantee access to electricity or utilities.
6. **Loudspeakers & Music:** No vendor shall operate loud speaker system. Loud music is prohibited at all times during the event.
7. **RV Parking & Camping:** There will be no overnight camping inside the fenced area of the swap meet or in the Main Parking Lot.
8. **Security:** The vendor is responsible for the security of goods in their own space. Vendors must keep their spaces open for business during all public admission hours. The fenced area is patrolled by the Lewiston Police officers, but is impossible to guard every space 100%. Vendors must cover goods with tarps overnight.
9. **Tables/Tarps/Chairs:** No tables, tarps or chairs are provided; you are responsible for providing your own.
10. **Taxes:** Vendors are responsible for filling out the ST-124 form and turned in if you are selling items.
11. **Teardown:** (Saturday) for the safety of pedestrians please do not tear down your space before 6pm

ANYONE IN VIOLATION OF ANY OF THESE RULES WILL LOSE THE PRIVILEGE OF BEING ABLE TO REGISTER FOR NEXT YEAR'S SWAP MEET.
